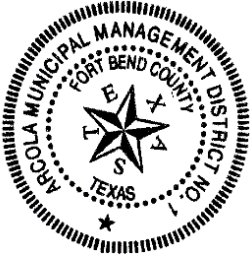
### ARCOLA MUNICIPAL MANAGEMENT DISTRICT NO. 1


The Board of Directors (“Board”) of Arcola Municipal Management District No. 1 (“District”) will hold a regular meeting, open to the public, on **Wednesday, May 10, 2023, at 6:00 p.m., at The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas 77478** to discuss and, if appropriate, act upon the items below.

1. Public comments.
2. Minutes.
3. Financial and bookkeeping matters, including payment of the bills.
4. Tax assessment and collections matters, including payment of the bills.
5. Master Service Agreement with Lake Pro, Inc.
6. Engineering matters, including:
  - a. authorization of design for projects in the service area;
  - b. approval of plans and specifications and authorization of advertisement for bids for the construction of projects in the service area, including:
    - i. Post Oak Pointe, Section 5;
    - ii. lift station No. 1 to serve the Fenn Road development; and
    - iii. offsite utilities to serve the Fenn Road development.
  - c. review of bids, award of contracts, and approval of Letter Financing Agreements for construction of projects in the service area, including City of Arcola Lift Station No. 2 Force Main.
  - d. approval of pay estimates and change orders and acceptance of projects, as appropriate, for construction of projects in the service area, including:
    - i. water, sewer, drainage, and paving to serve Post Oak Pointe, Section 3;
    - ii. hardscape & landscape to serve Post Oak Pointe, Phase 1;
    - iii. lift station no. 1 – replacement;
    - iv. Post Oak Pointe, Recreation Center; and
    - v. City of Arcola wastewater treatment plant upgrade.
  - e. update on City of Arcola water and sewer plant projects;
  - f. permits, deeds, easements, consents to encroachment, and utility commitment letters;
  - g. update on bond application; and
  - h. Utility Conveyance and Security Agreement.
7. Report on development.
8. Update on matters related to Reinvestment Zone Number 1, City of Arcola, Texas.
9. Next meeting date.
